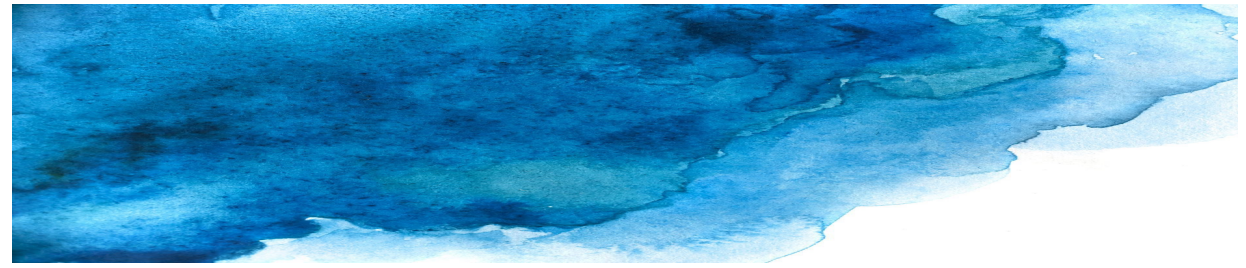

Marriage	the legally or formally recognised union of two people as partners in a personal relationship
Cohabiting	Living together
Civil Partnership	A legally recognised union of (usually) a same-sex couple, with rights similar to those of marriage
Common Law Marriage	When the couple lives as "being married," but without ever going through a formal ceremony or getting a marriage license
Commitment	Being dedicated to a person, cause or action

Marriage

Marriage is when two people, usually romantic partners and usually not related, join together to form a union. Most types of marriage are recognised by the law. There are different definitions of marriage around the world and in different cultures. The people getting married are called spouses. A man who is married is often called a husband, and a woman who is married is often called a wife.

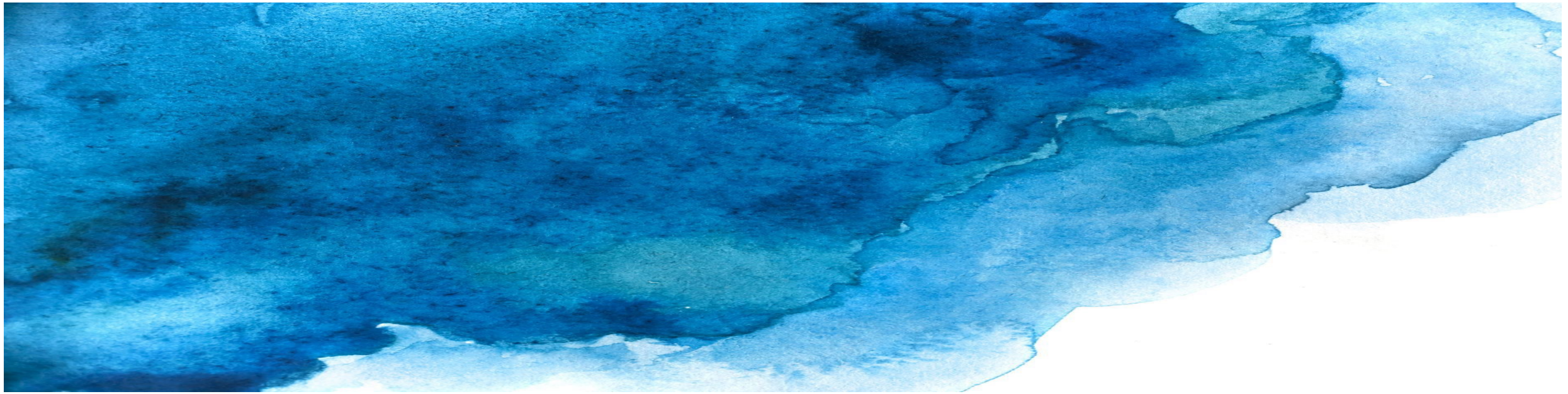
When spouses are married, they have certain rights and responsibilities. For example, if a married couple opens a joint bank account, the money belongs equally to the two spouses, regardless of who put most of it in there. A spouse will inherit all of the money if the other spouse dies. However, if a spouse dies owing money to somebody, those debts will be inherited by the other spouse. In the UK both gay and straight couples can get married

Civil Partnerships and Same-Sex Marriage

A civil partnership is defined as a legally recognised relationship between two people of the same sex who aren't related to each other. The people in a civil partnership are referred to as civil partners. In most of the United Kingdom, same-sex couples can legally get married and don't need to have a civil partnership. However, same-sex marriages are not performed or recognised in Northern Ireland. In many parts of the world, same-sex marriage has replaced or is replacing civil partnerships.

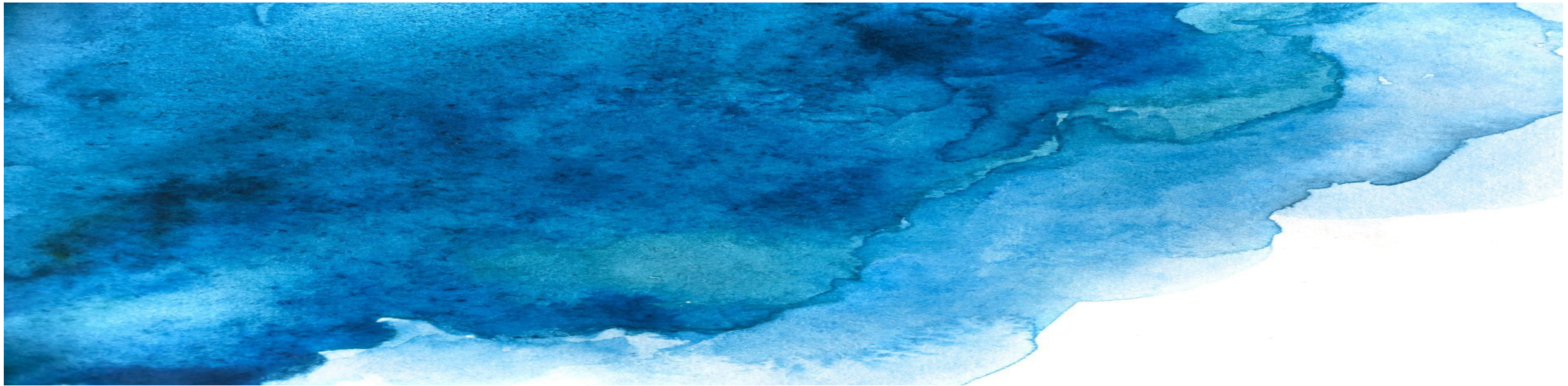
Civil partners have similar rights and responsibilities to spouses. For example, if one partner dies then the other partner is likely to inherit their property. Similarly, if one partner dies with debts then the other partner is likely to inherit those as well. A civil partnership is a legal union that can be entered into by two people who aren't related, the partnership has the same responsibilities as in marriage but the difference is that a civil partnership is entered into by signing a civil partnership document while marriage is entered by vows.

The Marriage (Same Sex Couples) Act 2013, was passed on 17 July 2013, and the first marriages of same sex couples took place on Saturday 29 March 2014.

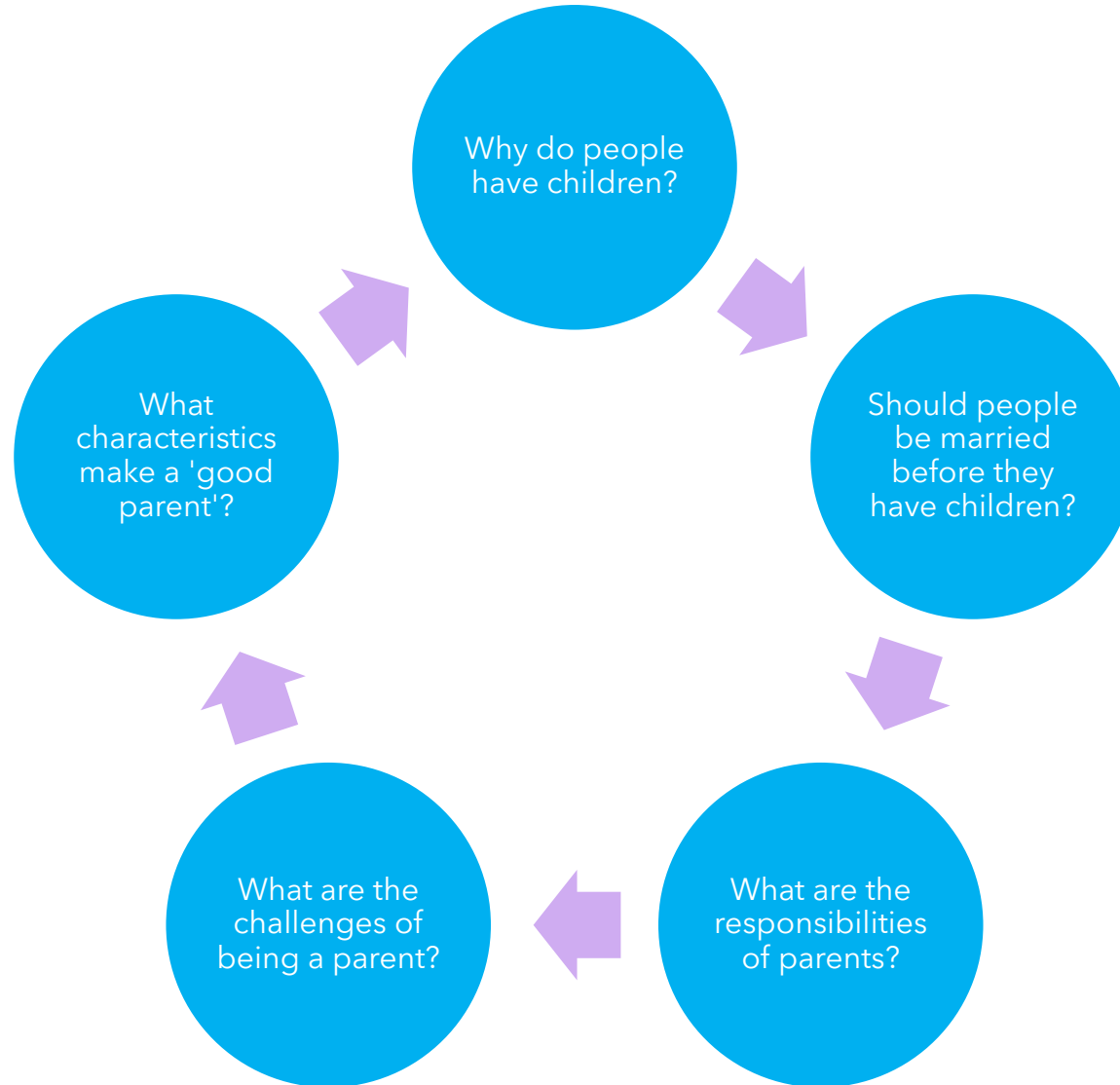

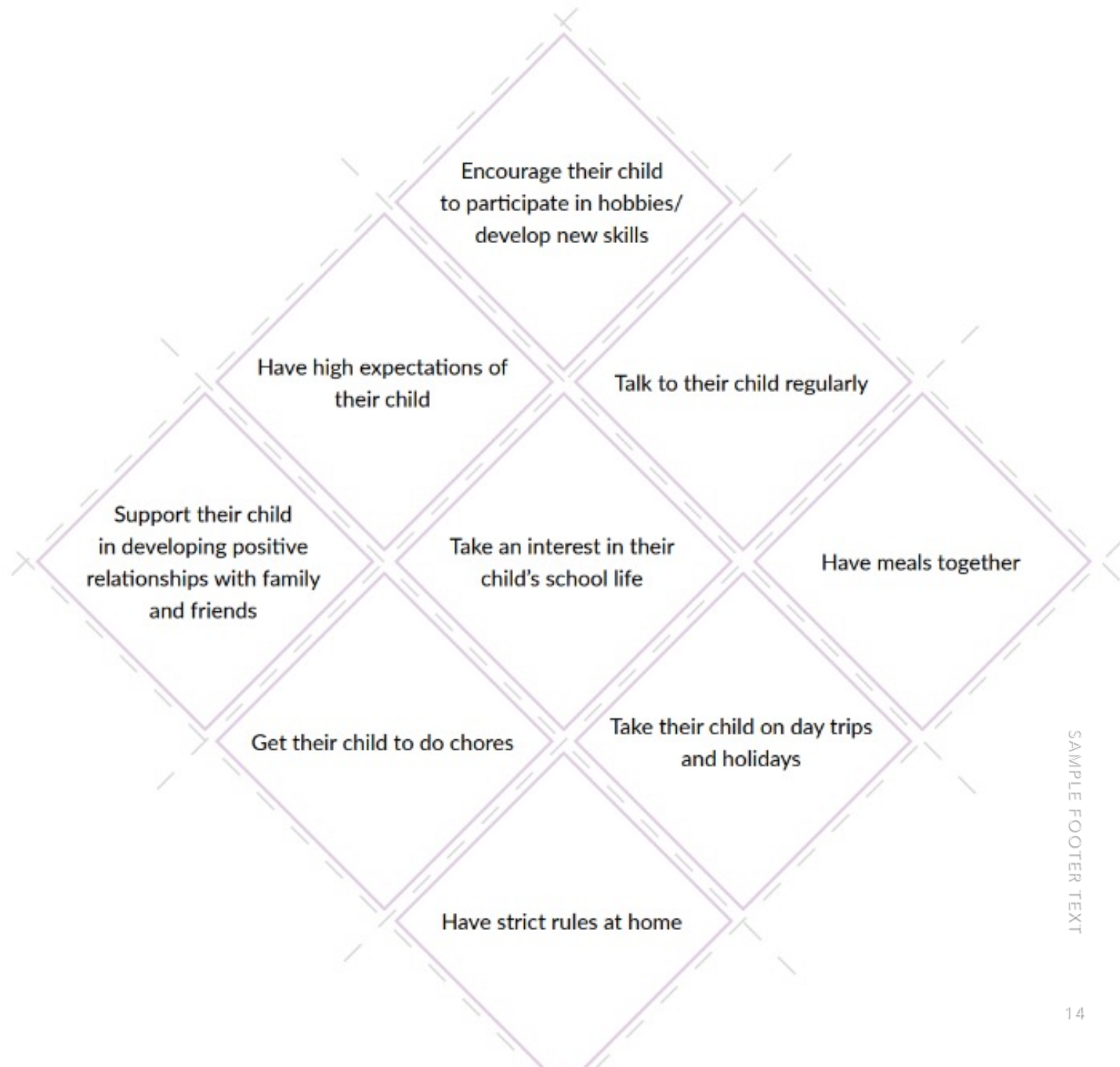
